IN THIS PROGRAM, UCC PROVIDES THREE CRITICAL LITERACY PROGRAMS YEAR-ROUND: A FOUNDATIONAL PROGRAM FOR EMERGING READERS IN PRE-K AND K, CALLED I CAN READ!, AN INTERVENTION PROGRAM TO ADVANCE THE READING LEVELS OF HIGH-RISK PRIMARY GRADE STUDENTS SIGNIFICANTLY BELOW GRADE LEVEL CALLED LEVELED LITERACY INTERVENTION (LLI), AND OUR CORE EDUCATIONAL ENRICHMENT PROGRAM (EEP), A BALANCED LITERACY PROGRAM SUPPLEMENTING FORT WORTH INDEPENDENT SCHOOL DISTRICT (FWISD) INSTRUCTION.
